Dawn Roy also applied for the Vice-Chair /Coordinator position and Adrian Liberto arranged to induct him until he was ready to take on the full responsibilities relating to the post.

#### 7. Election of the Auditor and Meeting Examiners

Adrian Liberto was elected as the auditor for the upcoming season with Finn Shields as sub-auditor.

#### 8. Discussion of 2023 Plans

Plans for the year 2023 were discussed, including the completion of the International Responsibility Index, enhancing the quality of journalism, aiming for more publications in print and exploring potential review sources.

#### 9. Financial Statement and Auditor's Report

Jonna Lappalainen provided a summary of the main expenses and income sources. In compliance with Finnish statutes, the majority granted discharge to all board members for their performance over the financial year.
